



## SAMPLE BEQUEST LANGUAGE

### BEQUEST FOR UNRESTRICTED PURPOSES:

I give, devise, and bequeath to the UNIVERSITY OF GEORGIA FOUNDATION, a non-profit corporation duly existing under the laws of the State of Georgia and located in Athens, Clarke County, Georgia, the sum of \$ \_\_\_\_\_ specific amount or \_\_\_\_\_ percent (%) of the rest, residue, and remainder of my estate as an unrestricted gift to benefit the University of Georgia.

### BEQUEST TO BENEFIT AN EXISTING FUND:

I give, devise, and bequeath to the UNIVERSITY OF GEORGIA FOUNDATION, a non-profit corporation duly existing under the laws of the State of Georgia and located in Athens, Clarke County, Georgia, the sum of \$ \_\_\_\_\_ specific amount or \_\_\_\_\_ percent (%) of the rest, residue, and remainder of my estate, for \_\_\_\_\_  
(Fund Name) to benefit the University of Georgia. Should circumstances later render it impossible or impractical to use this gift for the purpose herein designated, then the University of Georgia Foundation may use the gift for other purposes, adhering as closely as possible to my original intent.

### BEQUEST TO CREATE A NEW ENDOWMENT\*:
